- a) Ms. Frisco reported to the Commissioners the following office happenings:
  - 1. Reporting data on financial assistance approved for February 1 -28, 2021:
    - 1. Covid: 7/\$7000
    - 2. Emergency Financial Assistance: 56/\$33,812.48
    - Transportation: 20/\$628.00
      Indigent Burial: 1/\$1,000.00
    - 5. Kroger Voucher: 123 vouchers/\$6,150.00 (26 Veterans)
  - 2. Director attending New Service Officer School from April 19-23, 2021.
  - 3. Agent Orange Benefits Expanded to Bladder Cancer, Parkinsonism, and Hypothyroidism
    - 1. Developed new radio, TV, and newspaper ad
  - 4. Steven Strain is on board and setting up his office and preparing things for the new Mentor Coordinator position.
  - 5. Still waiting for a response from our top candidate for the Mentor Coordinator position. Non-select letters are on hold until our offer of employment is accepted.
  - 6. There were a total of 92 applicants for the Administrative Officer position, 49 were ORC 5901 eligible. Two applicants were internal with first consideration.
  - 7. Performance appraisals are being finalized for the staff.
  - 8. May 4-7 will be Spring Training
  - 9. The next Newsletter is in the works now along with the next round of advertising
  - 10. Our recent recognition of WWII Veteran, Nick Sabatino, who celebrated his 102nd birthday with a home visit from the Director and Deputy Director with balloons, card, certificate and challenge coin.
    - 1. Vet identified a need. We were able to acquire a light weight wheel chair (that his wife can handle) from the VA to meet their needs and handicapped transportation to medical appointments. Well Done!!
- b) Deputy Director Semsel reported the following:
  - 1. Working with Steven Strain on establishing new policies and procedures for the Veterans Legal Counsel and the Mentor Coordinator position.
  - 2. PeeWee Martin turning 100 this year. We plan to participate in the big celebration being planned by Belbrook.
  - 3. Currently going through old folders of Vietnam Vets and setting up a spreadsheet to assist with determining previous presumptive conditions and possible eligibility under the new rules.
  - 4. Wrestling with the new D365 financial accounting system and have requested training which is not available until April. Lessons learned now will help with the 2022 Budget request being prepared soon.

- b) Vice President Rojas reported the VA is now vaccinating Vets in the 50+ category.
