Legal Counsel Steve Strain presented to the commission the circumstances of the request. A veteran came to this office seeking assistance with an outstanding debt for a private ambulance transport. The veteran was transferred during a medical episode and incurred the debt for which the VA won't cover the cost. The amount, almost \$900 would create a significant issue for the veteran.

The Executive Director did share that a little more than \$400,000 of the budget was unused. 75% of that was budgeted Soldiers and Sailors dollars and \$100,000 of that was salaries.
