Kim Frisco presented an update along with comments by Bryan Suddith regarding the number of qualified vendors that are able and willing to bid on the project. From research in 2021 we have learned that Dodd's Monument company is the only local company able to do the work. They are also the company that built the monument. We have learned that most local granite companies are not interested in cleaning and restoratation work and all suggested Dodd's as a company that does restoration work.

Commissioner Fried moved to approve expenses not to exceed \$25,000 for the purpose of cleaning, restoration and repair of the memorial. Commissioner Theobald seconded the motion.

a) Transportation for Compensation Exams

Kim Frisco presented an issue that has come up recently. The office has received requests for VA required Compensation Exams outside of Montgomery County. Historically we have only transported Veterans within the county.

b) Ohio D-Day Event in Conneaut Ohio

Kim Frisco presented details around the annual Ohio D-Day re-enactment located in Conneaut Ohio. The event is a 3 day re-enactment of D-Day on the shores of Lake Erie.

Bryan Suddith presented a sample budget to transport 25-30 WWII veterans and aides and staff to Northeast Ohio for a two-day one-night bus trip. That estimated cost was \$15,000.

Commissioner Fried moved for approval in an amount to not exceed \$20,000 to execute a plan to make this trip possible for area WWII veterans. Commissioner Theobald seconded the motion.
