b) 2023 Budget Resolution

Deputy Director Semsel presented a budget proposal for 2023. He reminded commissioners that the Ohio Revised Code mandates a budget request to the County Commissioners prior to the last Monday in May.

The budget proposal accounted for increases in salaries, capital equipment, and soldiers and sailors relief funds as well as training and travel. The increase was below the allotted levy amount provided by the county and below the 10% maximum increase permitted by law.

The total proposal was set at \$2,600,000.00 for 2023.
