Director Frisco shared the legal, transportation and outreach reports as well as a review of the financial report from Deputy Director Semsel

Deputy Director Semsel presented the financial report. Estimated return to the county will be around \$285k. Will be at 90% expended. Commissioner Theobald requested a comparison of 2021 vs 2022 Soldiers and Sailors expenditures.

Coat and ALDI giveaway went better than expected. Record number of Coats and a quick distribution of the 250 ALDI cards. Commissioners were very pleased with the work on the giveaways.

Legal report was discussed by Steven Strain. Discussion occurred discussing the calculatable rate Strain is using to report veterans savings.

The Veterans Treatment Court graduated 5 Veterans in December.

Transportation Report presented by Bryan Suddith. Zip Code break down to be added to the report.

Executive Director Report, the December financial planning class was cancelled. Next class is January 10. The Director's Regional Roundtable will meet again in January. Kim detailed the MCVSC's involment in SOCHE's Veterans Program grant awart with the dispersal of \$100 Meijer Gift Cards to referred Veterans in Need.

We plan to advertise and hiring an additional VSO in the new year. Commissioner Theobald has been asked to join the Commission's Personnel Committee in preparation for the hiring.
