b) Fred Rojas spoke to the commission about the hiring of a civilian for a position that was not opened up to Veterans first. Mr. Rojas stated his concern that the commission is not adhering to the intent of the Ohio Revised Code. Steven Strain responded explaining the intersection of county, VSC and bargaining unit processes and procedures for hiring and that reviews by ODVS, County Prosecutor and County Commission HR found the Veterans Commission in compliance with 5901.
