Transportation Program 2023 Year End Review

Objectives

The Transportation Program was established to fulfill Ohio Revised Code 5901.03(H), the Montgomery County Veterans Services Transportation program is to provide regularly scheduled transportation for veterans to and from Veterans administration medical appointments, or other such medical appointments as are necessary for the Veterans care, through contractual agreements or through other arrangements determined to be the most cost effective.

Key Accomplishments in 2023

- Completed draft of Transportation program policies & procedures.
- Provided transportation to 2,601 medical appointments.
- 58% (1502) of all appointments assisted were to the Dayton VA.
- 27 disabled Veterans received Life-time Paratransit accounts through our Transportation Program, increasing their independence and access to essential services.
- Created partnership with Catholic Social Services to refer clients to their
 Volunteer Driver Program for cross-county medical appointments.

Key Insights from 2023

- 173 Montgomery County Veterans received Transportation assistance.
- 43% of all Transportation clients have met with a MCVSC Service Officer for VA benefits counseling.
- 14% of all Transportation clients have received Legal assistance from Steven Strain.
- Tri-weekly dialysis treatment is the most common assisted appointment.

Transportation Program 2023 Year End Review

Issues

- Veterans needing transportation assistance to out of county C&P exams on short notice.
- Veterans cancel Colonoscopy appointments due to lack of signed release transportation.

Open Items

2023 RTA Client Survey

Future Goals

- Increase Transportation client use of other MCVSC services.
 - > 50% for benefits assistance with Service Officers
 - ➤ 25% for legal assistance with Steven Strain
- Increase awareness of available Transportation services through community outreach, social media, and in-office education.
