V. Public Comments

- Cheryl Habel Mission BBQ, 2500 Miamisburg Centerville Rd., will be honoring Vietnam Veterans with a FREE sandwich on National Vietnam War Veterans Day, March 29.
- Kevin Keller, AMVETS Post 24, stated that he is in attendance today as an observer.
- Fred Rojas, Commander VFW Post 9550, announced the VFW National Convention will be held in Columbus Ohio August 9th through the 14th. He invited Montgomery County Veteran Service Commission to come and set up a table. Mr. Rojas stated that the MCVSC Meeting minutes are hard to find on the website and suggests that they are made more easily accessible. Mr. Rojas also stated that he read in past meeting minutes that removing Veteran Service Officers (VSO) from the Dayton VA was discussed. He expressed concern that this action could potentially limit resources available to veterans and he is against the idea. A discussion was had about the random office hours and that it was difficult to reach the VSO's at the VA. Deputy Director Suddith responded that MCVSC VSO's are accredited by the Ohio Department of Veteran Services and they travel to the VA weekly and will go into hospital rooms to see veterans who are in-patient to assist with their claims. Mr. Rojas asked the Commission how the Montgomery County Veteran of the Year award was determined. Mr. Suddith and President Hay responded that MCVSC does not play a role in that process.
- Commissioner Fried addressed the guests present and explained that the VVA in conjunction with the American Legion will award (6) \$1,000 scholarships to high school students. Information that he would like to make available to them.

VI. Old Business

a.) Consideration of Soldiers and Sailors Financial Assistance for the period of February 1 - 28, 2025. Commissioner Theobald moved to approve, and Commissioner Dare seconded the motion.

Discussion: After reviewing the denial list, Mr. Howley asked if guidelines are available to help the VSO's and management determine a financial emergency. Deputy Director

Suddith explained that there are guidelines, and each case is looked at individually. President Hays pointed out that all policies and procedures are reviewed and approved by the Commission. They could be reviewed again if requested.

 - Ashley Rehbein will start on March 17 as the new Mentor Coordinator / Outreach Coordinator. She will begin to expand our outreach programs and recruit mentors for our Veterans Treatment Court.
 - We are looking forward to our official library event, in which we will be hosting events throughout the county on various days during the month of May. We will be running newspaper ads and Kim will be on Living Dayton to promote this event.
 - An updated staff directory was provided to the Commissioners.

Commissioner Theobald requested that management look into updating <u>www.mcvsc.org</u> to create a better mobile website experience.

 - ➤ The last post meeting was held on 3/10/2025 and new veterans were voted into leadership roles.
