Upon exiting executive session Executive Director Frisco provided a staff update. Ashley Wendler, our new Mentor Coordinator, is doing great. She has attended her first Veteran Treatment Court and has held her first mentor meeting. She is currently working on changes that the mentors have requested, such as support groups at the VA. The mentors have also requested to begin having regular lunches with Judge Melnick, which Ashley is working to organize. Veteran Treatment Court Graduation will be June 18th.

Director Frisco also advised the commissioners that yesterday, April 8th was Courtney Griffith's last day as our Community Health Worker. She will be rejoining the YWCA as the Director of the Domestic Abuse Program. While here Courtney developed an outstanding case management program, a resource guide, new forms and a transition plan for her successor.

After the exit interview with Ms. Griffith and discussions with Judge Melnick, Executive Director Frisco suggested changing the position description for the job vacancy.

- a.) Executive Director Kimberly Frisco presented the Staff reports

 - Paul and Amie attended New VSO school and passed their exams. They will attend the national accreditation school next week.

 - There will be a staff meeting today at 3:30 p.m. the commissioners are invited to attend.
 - The VSO's will be attending the National Conference in July.
 - Ms. Frisco shared a letter from Montgomery County resident, Dr. Tom Hardy, praising Mr. Fried's presentation of our 2024 Annual Report.
 - She also shared a thank you card from a veteran.
 - Discussion was had regarding the budget, encumbrances and ensuring there will be enough money for the rest of the year.
 - Management is currently working on editing the Financial Application.
 Commissioners Theobald and Fried offered suggestions regarding layout, wording and some details that they would like to see in the application.

 - We are seeing a lot more appeals and requests for higher reviews of

service claims. Commissioner Theobald would like to see a report on service claims that are denied or claims that are in the appeal process. Commissioner Fried added that he would also like to see a report on claims in process.

- Several bus passes were issued along with food vouchers to help veterans in need of being able to get to the grocery store.
- Commissioner Fried states that he anticipates an increase in the transportation budget due to rising costs.
- Commissioner Theobald complimented Director Frisco and staff for keeping the cost per trip low.
- Per Commissioner Fried's recommendation, there will be a mentor recruiting event to be held in August, Judge Adkins is slated to speak.
- A variety of outreach programs have been completed and several more are scheduled to take place in the upcoming weeks and months, please see the attached report for more information.
- Commissioner Theobald requested that an email be sent to the commissioners with addresses for the library events to be held in May.

meeting and requested that the following be sent out to staff: Butler County working with the VA to house homeless veterans at a local hotel. Clinton County began an optical program for vets., Greene County offers a SAFE program for suicide prevention, Warren County hosts a mentor appreciation breakfast for VTC mentors, another veteran service commission provided bus trips to local events for veterans, and recognized veterans who are in hospice.

Claims



One of the primary missions of the Veterans Service Commission is assisting and advising Veterans who are making a claim for disability compensation. Our team of 7 Nationally and State Accredited Service Officers filed more than 600 claims for compensation. More than 80% of those claims had a positive award.

Consistently since 2020, the amount of reported claim awards has increased annually year over year. More than 80% of all claims filed in 2024 were granted an award. Those monthly awards, one time retro pay and single payments, amounted to more than \$8.5 million for 2024.


More than 40% of all awarded claims went to Vietnam Fra Veterans, 2024 saw a record number of Vietnam Era Veterans (service between August 1964 and May 1975) making application for disability compensation. Most of these were PACT Act related.



Budget

At-A-Glance

The 2024 Budget Appropriation was set at \$2,744,858.44. Of that appropriation \$2,402,518 was expended. Expenditures represent 90% of the budget allocations. The majority of unused budget was due to unfilled vacancies.



Financial Assistance \$552,391.00

More than 690 applications for Financial Assistance were taken in 2024. More than \$500,000 was awarded to Veterans in need of rent, mortgage, utility and food assistance. Additionally more than \$32,000 was awarded to more than 34 applications for indigent burial assistance.

Increased food and housing costs drove an increase in the number of Financial Assistance applications this year.

The continued partnership with Community Action Partnership (CAP) resulted in a lower expenditure of Utility Assistance this year over last year. This allowed more families to be served in 2024 than in 2023. More than 100 Veterans received assistance from CAP.

Transportation

\$87,614.00

From 2020 with an average of 18 rides per month to 2024 where the monthly average is more than 200 rides, no program has grown faster.

More than 2004-rides per month.

Medical appointment transportation continues to be one of the most popular services provided by the Commission.

Driven by partnerships with RTA and private liveries, Veterans are transported to the VA, WPAFB, dialysis, and routine medical appointments daily.

Under the direction of Loren Scott, Transportation Coordinator, the program boasts an average of less than \$30 per roundtrip.

Coat Giveaway

For the 5th year qualifying Veterans were able to pick up a new winter coat, hat, scarf and gloves. This program runs from November through January. Annually more than 300 new winter coats are distributed to Veterans in need.

Aldi Gift Card

278 gift cards for food from local Aldi Supermarkets were distributed to indigent Veterans during the 2024 Holiday Season. Valued at \$200 each, this program provides holiday meals to qualifying Veterans with household incomes at 250% or below the federal poverty line. This program is scheduled for a return in 2025.

Dental Assistance

The Dental Assistance Program provided routine dental care to a number of Veterans who lacked dental insurance or access to care. Local providers partnered with the MCVSC to insure that every Veteran who needed routine preventative care and more were treated. This year \$6,165 was spent on Veteran Dental Care.

Outreach

News appearances, parades, fairs, festivals, concerts, poker runs, Post events, Golf Outings, Base events, non-profit partnerships and more totaled more than 50 occasions staff represented MCVSC in our community.

- Emergency financial assistance to eligible Veterans and family members
- No cost legal consultations for Veterans
- Medical transportation to any medical appointment in Montgomery County
- Dental vouchers for low-income veterans to receive basic annual dental care
